CONTEXT & METHODOLOGY

To inform humanitarian cash programming, REACH conducted a Rapid Market Monitoring (RMM) of 20 major markets in northwest Syria (NWS), in response to the rapidly depreciating Syrian Pound (SYP) against the US Dollar (USD) and reports of fuel types being unavailable.

The 20 markets were selected based on recommendations by REACH Team Leaders, who prioritised markets witnessing significant price increases, as well as markets reportedly supplying key commodities to a large number of communities. This RMM assessed the availability and prices of the 18 items that comprise the Survival Minimum Expenditure Basket (SMEB; for SMEB components, please see our regular monthly Market Monitoring Exercise (MM)), which represents the minimum, culturally adjusted items required to support a 6-person household for a month. The commodities are typically sold in markets and consumed by average Syrian households. Items include fresh food and bulk food, non-food items (NFIs), water, fuel, and cell phone data. For this RMM, enumerators attempted to collect three minimum pricepoints per item per market.

The data for this RMM exercise was collected by REACH on 1 March 2020. Data collection was conducted both remotely and directly through market vendor key informants (KIs) in markets which are usually covered by the MM. Comparisons were made to the February MM for Northwest Syria (Data collection 10-17 February). Findings should only be considered as indicative of the current prices and reported unavailability of items in the assessed markets as reported by market vendor KIs. MEDIAN INFORMAL EXCHANGE RATE ACROSS 20 ASSESSED MARKETS



KEY DEVELOPMENTS

Unavailability of fuel

Since the escalation of conflict in northeast Syria in October 2019, importing fuel to NWS has become increasingly difficult, as indicated by the growing lack of availability in various transportation fuel types reported by vendor KIs. Across all 20 assessed markets, high quality fuel (petrol/diesel) was reported as unavailable, whereas vendor KIs in 17/20 markets reported unavailability of manually refined petrol and vendor KIs in 15/20 markets reported unavailability of manually refined diesel. Similarly, manually refined kerosene (used for heating and cooking) was also reported as unavailable by vendor KIs in 15/20 assessed markets.

Continued depreciation of SYP against USD

The median reported informal exchange rate across 20 markets was recorded at 1,120 SYP to the USD. This marks a 7% increase since the regular MM in February.

Reported increases in prices of SMEB food component across most markets

This RMM recorded a 5% increase in the price of the SMEB food component compared to the recorded price across the same markets in the regular February MM - from 73,590 SYP to 77,515 SYP. At the market level the cost of the SMEB food component reportedly increased across 13/20 markets with the biggest increases being reported in Ghandorah (15%) and Dana (12%).


N/A - Median price of transport fuel across assessed markets

Markets in northwest Syria continue to face supply disruptions. The costs associated with importing fuel affects both NWS fuel availability and prices. The regular February MM reported that manually refined kerosene was unavailable in 79% of comparable markets. All types of transport fuel were unavailable in 68% of comparable markets and fuel vendors reported widespread procurement issues, mainly driven by the increase of prices and cut-off of regular supply routes. **This RMM similarly recorded unavailability of most fuel types across assessed markets.** High quality fuels (petrol and diesel) were reportedly unavailable in all assessed markets. According to fuel vendor KIs, lower quality fuels such as manually refined diesel were only available in 5/20 markets and manually refined petrol in 3/20 markets (see page 3). Hence, due to low availability of fuel types across markets, data from this RMM did not allow for a calculation of a median average transport fuel price.

SMEB Food Component

77,515 SYP - Median price of SMEB food items across assessed markets

The median SMEB food component price was slightly higher than the regional median price recorded during the regular February MM, which was 73,590 SYP across comparable markets. The increase was mainly driven by increases in food items such as rice (11%), lentils (10%), potatoes (11%), chicken (10%) and bulgur (6%). This RMM also recorded decreases in some food items, such as tomato paste (-10%) and onions (-14%).
