Recommendations

Recommendation 1 : UNFPA should focus more strategically in this country programme and in planning the 6th country programme on identifying, prioritizing and targeting the most vulnerable, marginalized and high risk people and groups. The strategy should emphasize prevention of sexual and

reproductive health issues and gender-based violence and should clearly target the most vulnerable and marginalized with strategies to reach them. Integration of the programmatic areas and mainstreaming gender and youth should underpin the strategy.

Advocacy should be stronger for resource sharing with donors, partners and UN agencies working on similar issues. Since gender equality is already a government priority, advocacy can take place through women's empowerment interventions, research, and studies demonstrating the benefits of investing in women and girls, especially within the government.
